• May 31,2022 (Operating Fund) balance was \$ 25,733.96 as of Dec 31,2022 \$24,576.09. May 31,2022 Servus (Casino Fund) balance was \$10,186.17 as of Dec 31, 2022 \$21,008.61 and ATB (GIC) \$32,589.72.

• Revenue for WMBA ATB (Operating fund) has decreased by \$1,157.87 as of Dec 31st. Expenses were \$8770.51.

• Revenue for Servus (Casino Fund) has decreased significantly due to ball season not being cancelled or with low registration as pervious years due to the pandemic. WMBA association was able to use the casino funds for equipment for the Facility/Diamond, paying umps and tournament fees. Expenses as of May 31st was \$13,091.43.

• The ATB GIC matures November 14, 2022 (Non-redeemable GIC earning 0.60% interest). WMBA Association will need to determine if we continue investing or redeem a portion for 2023 season. • AGLC mails or emails the financial report that needs to be completed. Treasure hasn't received the report to complete in the 60 days required to be submitted.


